Directions to Hilton Atlanta:

Traveling 75/85 South:

Exit at 249A (Courtland Street). This is a one way street and the hotel is one block ahead on your left.

Exit at 249B (Peachtree Street). At first light, turn right on Peachtree Street. Next light, turn left on Ralph McGill Blvd. Next light, right on Courtland Street. The hotel is one block on your left.

Traveling from East/West I-20.

Take 75/85 North and follow directions for 75/85 North.

From GA 400

Follow GA 400 South to I-85 South. Follow 85 south and take exit 249A (Courtland St). This is a one way street and the hotel is one block ahead on the left.

Awards

Qualifying ribbons will be awarded to each dog/owner team who achieves a score of 170 or better. Placement rosettes will be awarded to the top 5 high scoring teams in both A and B Classes. Championship rosettes will be awarded to all teams completing a Championship title. Special Award opportunities at these trials!

General Information

Entries will not be accepted without an APDT Rally registration number. To obtain a registration number, please obtain a registration form from the APDT Rally website and mail directly to APDT Rally. Registration numbers must be obtained BEFORE entering this trial!

- This is an indoor trial with a 40x70 carpeted surface. Ample crating space.
- Please bring your own food and water for yourself and for your dogs, as there will be limited food available.
- Dogs are NOT permitted in any part of this hotel except the trade show where the trial will be held. Please take note of this and plan accordingly.
- There will be no refunds for absent entries. Refunds will be made for withdrawn entries only if request is made prior to closing date and can be filled by the waiting list. Refunds will be made for bitches in season if request is accompanied by a note from the exhibitor's veterinarian.
- Please make checks payable to **APDT RALLY**.
- **No prong or choke collars will be allowed on show grounds.**
- **Move ups:** Closing date for Move ups is October 8.

Notice to Competitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of APDT Rally Obedience rules and regulations including but not limited to the following rules regarding entry:

- ◆ This trial is open to all dogs being at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- ◆ All dogs must be registered with APDT Rally to compete. Forms are available at www.apdt.com.
- ◆ Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- ◆ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- ◆ The organizing committee may refuse any entry for any reason.

In addition,

- ◆ THERE SHALL BE NO REFUND for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- ◆ Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check where notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler.
- ◆ No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
- ◆ All dogs shall be shown in a flat buckle or snap collar, plain harness, or properly fitted martingale (limited slip) collar. No choke collar, prong collars, shock collars, no-pull harnesses, martingale leads, or head collars are allowed.
- ◆ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. All video, broadcast, and telecast rights for this event are the exclusive property of the APDT or the trial host(s).
- ◆ Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- ◆ Upon successful completion of an exercise, the owner may choose to briefly pet or touch the dog as a reward. The owner may also choose to give the dog food as a reward. Food may NOT be used as a lure to help the dog complete an exercise. Food rewards must be contained in pockets or hidden treat pouches and only be present in the owner's hand in between exercises. Any petting, touching, or feeding that significantly interrupts the flow of performance shall be scored accordingly.
- ◆ Dogs must remain under control at all times whether on or off leash while on show grounds. Day kenneling only is permitted, unless otherwise posted at the show site. Please pick up after your dog and yourself.
- ◆ APDT's official Rally-O Rules and Regulations are hereby incorporated by reference, a copy of which may be obtained by going to APDT.com/RallyO/index.htm.
