

## Chapter 15 Sanctioned Seminars

APDT Rally Judge and Representative Continuing Education Sanctioned Seminars provide an educational opportunity for not only trial officials but the general public as well. These seminars may be hosted by any club, organization or individual and are subject to APDT Rally approval. Continuing Education Sanctioned Seminars will also be presented at the yearly APDT Conference. Continuing Education seminars are not working seminars. Seminar hosts may allow attendees to bring their dogs but dogs will not be worked unless they are designated demo teams. APDT Rally will provide seminar outlines and video to each seminar host.

Criteria for approval:

1. Must be presented by an approved APDT Rally Senior Representative.
2. Must be presented according to APDT Rally Continuing Education Seminar Outline.
3. Must include a live demo or video of each Level.
4. Must be made open to the general public. Seminar hosts may limit number of attendees.

### General

The seminar will be presented according to the Seminar Outline and materials provided by APDT Rally to both the presenter and seminar host.

APDT Rally will issue a Certificate of Attendance to all attendees. Seminar host must submit a signed Attendance Form to APDT Rally within ten business days after seminar has been held.

No application fee is required. However, seminar hosts must submit an Administrative Fee in the amount of \$5.00 per attendee to APDT Rally.

APDT Rally will compensate presenters in the amount of \$100 per seminar. Presenters must submit a Request for Payment form (signed by seminar host) to the APDT Rally office in order to receive compensation.

It is suggested that seminar hosts charge an attendance fee of no more than \$25.00 per person
